Strategic partnerships continue with outside partners to produce public art including murals, producing community events, and art in public/private locations such as hospitals, malls, hotels, etc.

A significant portion of the "other programs" category is comprised of "Collaborative Programs." Collaborative programs represent mission-related alliances formed in an effort to generate new areas of exposure and sales for ArtServe and ArtServe member artists. Collaborative partners can include venues, such as a hotel or performing arts center gift shop, where ArtServe member items are sold to the public.
